Course delivery & structure:

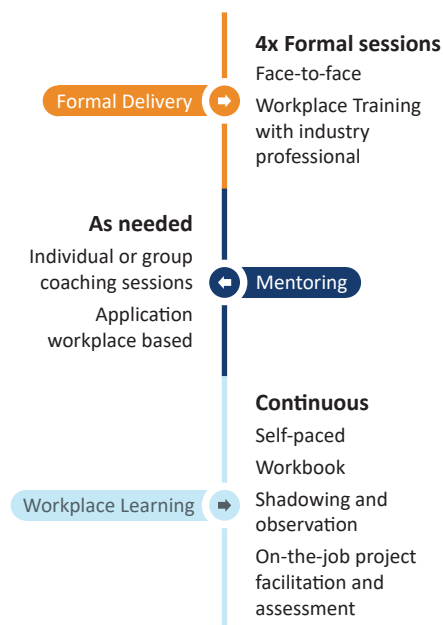

 - up to 3 units may be selected from any currently endorsed Training Package or accredited course.
